

TOWN OF NEW HAVEN
APPLICATION FOR VARIANCE INSTRUCTIONS

1. Meet with Code Enforcement to determine if Variance is needed.
2. Pay close attention to submission deadlines as they are now strictly enforced to allow time for notification of all parties.
3. Fill in all information on application form.
4. Complete Part 1 of Appendix B Short Form Environmental Assessment Form. Part 2 is completed by the Planning Board.
5. A current survey must accompany the variance application if one exists.
6. Include a drawing to scale, showing all property lines, existing and proposed buildings, driveways, wells, septic systems, etc. Include dimensions of all structures and distances between structures and to property lines, wells, and septic systems. The drawing must show entire parcel.
7. A copy of the deed and or land contract must accompany application (only one copy is required)
8. Turn completed application/packet to Code Enforcement Officer.
9. The meetings are held on the third Wednesday of the month at 6:00 pm in the meeting room at the Town Hall. You must attend the meeting.
10. After the Planning Board has reviewed and approved the application, a Public Hearing will be scheduled.
11. The Planning Board will send letters to all adjacent landowners informing them of the proposed variance allowing them to comment. Comments from your neighbors will be taken into consideration. Approval or objections from neighbors do not guarantee approval or denial of your application.
12. A Letter of Determination will be provided to you and a copy to Code Enforcement. For additional requirements, please follow-up with Code Enforcement.
13. If you have any questions, call the Town Clerk, and ask for the Planning Board Chairperson to contact you.
