


**ASSESSOR MONTHLY REPORT**  
**October 2018**

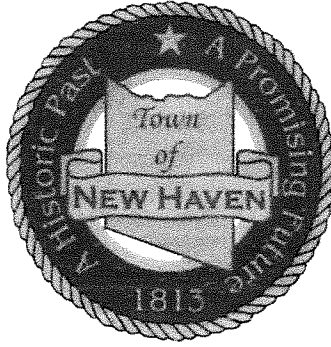

The reason for the early preparation is because NYS Tax and Finance changed the procedures for filing for the Enhanced Star and for the Senior Citizen forms. It was felt that it would be best to send them out early in case of property owners being confused on how to fill out the required forms. The other exemptions: Agricultural, Clergy, Disability, etc. will be sent out in January as usual.

Other than the above, the normal filing, telephone calls, sending out Certificates of Compliance and/or Occupancy, Sales Verification forms.etc. were performed by the assessor.


